That there is hereby authorized to be executed by the Chairman on behalf of the Board of Commissioners the Release of Purchase Options dated this date which is attached to this resolution, and the Recorder of Fayette County, Ohio is authorized and directed to accept and file the same for record for the purposes therein contained and for the purposes contained in this resolution.
3. That the Recorder of Fayette County, Ohio is hereby further authorized and directed to cancel and release of record all documents and instruments referred to hereinabove, and any and all such other instruments between the County and Seller, and or their predecessors in title, which may be of record in such office affecting title to any such real property in the name of the Seller and/or their predecessors in title, and to take all such further action as may be necessary and appropriate to extinguish all right, title and interest of the Board of Commissioners and Fayette County therein, all without the necessity of having any order from any court of competent jurisdiction regarding the same.
