PROPOSAL ACCEPTED ROOF REPLACEMENT 135 S. MAIN STREET, FAYETTE COUNTY BOARD OF ELECTIONS

It was moved by Mr. Dean and seconded by Mr. Garland to accept the proposal presented T&M Roofing & Sheet Metal, 2965 Adamsville Road, Zanesville 43701 for the replacement of the roof on the building known as the Board of Elections, 135 S. CONTRACT – FAYETTE COUNTY CHILD SUPPORT ENFORCEMENT AGENCY AND FAYETTE COUNTY COMMON PLEAS CLERK OF COURTS, IV-D

CSEA initiated filings of a document on the case termination Supreme Court of Ohio Form B Report, categories G, I & J or on the Common Pleas Court of Court Closed Cases in-house tracking form for CSEA IV-D, Administrative Paternity/Child Support Orders, Lump Sum Orders and Orders Terminating/Recalculating Support due to Emancipation, Adoption, Death or Change of Custody.
