It was moved by Mr. Garland and seconded by Mr. Anderson, per the request of Faye Williamson, Director, to approve the contract between Fayette County Department of Job and Family Services (Agency) and Advantage Family Outreach and Foster Care, 445 W. Longview Ave., Mansfield, 44903, for the placement and related services for children in the care and custody of the Agency. Effective term of this contract is from January 1, 2020 through December 31, 2020. Maximum amount payable under this contract is \$125,000.00. RESOLUTION AUTHORIZING AN AGREEMENT WITH THE VILLAGE OF OCTA,
OHIO FOR THE TRANSFER OF REAL PROPERTY FROM THE VILLAGE TO
FAYETTE COUNTY

It was moved by Mr. Anderson and seconded by Mr. Garland to adopt the following resolution:

Whereas, the Village of Octa, Fayette County, Ohio is the owner of a certain parcel of real property being approximately 0.074 acre situated on West Lancaster Road NW, in the Village, Fayette County, Ohio, and being permanent parcel no. 09001500101001, Fayette County, Ohio Auditor's Office, further described in the agreement attached hereto and incorporated herein as Exhibit "A," and,

Whereas, Fayette County is the owner of a certain parcel of land of approximately 1.06 acres directly adjacent to and abutting the parcel which is owned by the Village and described above, and,

Whereas, the Village and the County have determined that the combination of the two parcels of land will more directly benefit the Village and the County and the residents of the same, and thereby be more for the benefit of the public interest, now therefore,

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF FAYETTE COUNTY, OHIO AS FOLLOWS:

1. That the Board of Commissioners be and it is hereby authorized to enter into an agreement with the Village of Octa, Fayette County, Ohio for the transfer and conveyance to the County of Fayette of all the Village's right, title and interest in and to the parcel of land described in the agreement referred to herein above which agreement shall be in substantially the form as the agreement attached hereto as Exhibit "A."
2. That the Board of Commissioners be and it is hereby authorized to do all other things and take all other actions which it may deem necessary or advisable to carry this resolution and such agreement into full force and effect.
