CHANGE ORDER #1 -SUNESIS CONSTRUCTION, FAYETTE COUNTY AIRPORT TAXIWAY, PHASE I

It was moved by Mr. Anderson and seconded by Mr. Garland to accept the following change order #1 request from Sunesis Construction that serves to address need for cement stabilization at a cost of \$81,502.98 using unsuitable material onsite and chemically stabilizing it with cement (cost does not include curing coat). CONTRACT - FAYETTE COUNTY DEPARTMENT OF JOB AND FAMILY SERVICES AND FAYETTE COUNTY BOARD OF DEVELOPMENTAL DISABILITIES, HELP ME GROW, EARLY INTERVENTION SERVICE COORDINATION

It was moved by Mr. Garland and seconded by Mr. Anderson, per the request of Faye Williamson, Director, to approve the contract between the Fayette County Department of Job and Family Services acting on behalf of Fayette County Family and Children First Council and the Fayette County Board of Developmental Disabilities for Help Me Grow Early Intervention Service Coordination to children birth to three. The maximum payable under this contract \$76,901.00 and will be funded by Part C of the (IDEA), Individuals with Disabilities Education Act for the contract period July 1, 2020 through June 30, 2021.
