**CONTRACT - WELLER'S PLUMBING AND HEATING, FAYETTE COUNTY  
COURTHOUSE**

It was moved by Mr. Garland and seconded by Mr. Anderson to enter into contract with Weller's Plumbing and Heating, Inc., 429 S. Washington Street, Greenfield, 45123, for the labor and materials to recover refrigerant for reuse, remove compressors and reinstall new ones with two new inverter boards at the Fayette County Courthouse. **LEASE AGREEMENT - MODERN OFFICE METHODS, OWNER, LANIER COPIES**
